Introduction

Welcome to Coastwatch Redcar's privacy policy.

The charity respects your privacy and is committed to protecting your personal data. This privacy policy will give you information on how we collect and use your personal data. This privacy policy will also tell you about your privacy rights and how the law protects you.

Important information and who we are

Coastwatch Redcar is a UK registered charity (1177709) assisting in the protection and preservation of life at sea and the controller and responsible for your personal data.

You have the right to make a complaint at any time to the Information Commissioner's Office (ICO), the UK supervisory authority for data protection issues (www.ico.org.uk). We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy policy of every website you visit.

The data we collect about you

We respect the rights and privacy of our supporters and adhere to our Privacy Policy at all times. We take our obligations very seriously and will never share your details with any other charity or third party for their own purposes.

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

The personal data we collect includes:

- first name, last name and title;
- Boat details, name, engine, type of hull, builder or anything that may identify that vessel to an individual,
- address, billing address, email address and telephone numbers;

- details and information, you provide in any communications between us, in for example, emails, telephone calls and letters.
- Serial numbers and ID codes for certain safety equipment you hold
- If you make a donation through our website or our social media site we do not keep you account details our third party payment processors (My Donate BT) have this responsibility.
- Photographic images.

We do not collect any special categories of personal data about you.

It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.

How is your personal data collected?

We use different methods to collect data from and about you including when you:

- fill in forms or correspond with us by post, phone, email or otherwise;
- enquire about our activities;
- make a donation (Only names and addresses)
- use our website; or
- contact us through our social media site.

Purposes for which we will use your personal data

We may process your data for the following purposes:

Marketing

We will never put pressure on you to make a donation and will be especially careful and sensitive when engaging with people, including the elderly, who may be vulnerable. If you do not want to give or wish to cease giving we will respect your decision.

We will not use your personal data to approach you to make donations. If you wish to, you can do this through our website or our social media site.

Disclosures of your personal data

There may be occasions when we have to share your personal data with the parties set out below:

Emergency Services

- **Maritime and Coastguard Agency**
- **Police**
- **Fire Service**
- **Ambulance Service**
- **RNLI**
- **One of our watch keepers who may be dealing with an incident you are involved in.**
- **We may transfer your personal information to a third party if we're under a duty to disclose or share your personal data in order to comply with any legal obligation**

We require all third parties to respect the security of your personal data and to treat it in accordance with the law.

International transfers

We do not transfer your personal data outside the European Economic Area (EEA).

Data security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed.

Data retention

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

Your legal rights

We are a small charity with limited fundraising resources but strive for the highest possible standards. We welcome comments and suggestions which may help us improve our services. Under certain circumstances, you have rights under data protection laws in relation to your personal data. You have the right to:

- Request access: to your personal data (commonly known as a “data subject access request”).
- Request correction: of the personal data that we hold about you.
- Request deletion: **of personal data we hold about you in certain circumstances.**
- Object: **to the way we use your personal data, in certain circumstances, for the reason that you object to the legal basis we rely on to use your data.**
- Restrict: **the way in which we use your personal data in certain circumstances.**
- Request the transfer: of your personal data to you or to a third party.
- Withdraw consent at any time: where we are relying on consent to process your personal data.
